**ORDER**

**Subject: Lifting of e-auctioned cargo from primary location**

The Government vide Order No. 03/54/2021/Major/Mines/2945 dated 31-1-2023 had directed all the winning bidders and other parties who have purchased the cargo from the winning bidder but not lifted the same from the primary location of e-auction (primary location means the location of cargo at the time of e-auction) to lift the cargo on or before 31-3-2023 as one final opportunity. However, many requests have been received by the Government to extend the time for lifting the cargo citing various reasons. Accordingly, Government has decided to give time up to 31-5-2023 as final opportunity to lift the cargo from the primary location subject to the following.

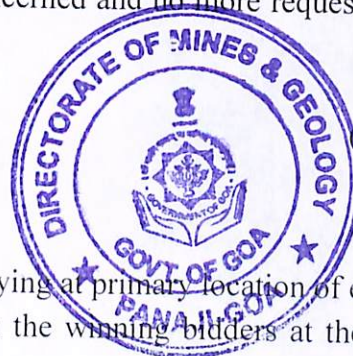
- a) The parties who have already been issued transit permit to lift the cargo but could not lift the cargo by 31<sup>st</sup> March 2023 are allowed to transport the same using the same transit permit to the extent the quantity mentioned in the permit. .
- b) In order to obtain fresh transit permit for lifting the cargo, all the winning bidders or the parties who have purchased the cargo from the winning bidder have to furnish complete details of cargo owned by them at the primary location as given below. This information must be received by this office on or before 19-4-2023 positively.
  - 1) All the winning bidders of e-auctions and other parties who have purchased the cargo from the winning bidders have to submit the details of cargo held by them at the primary location giving e-auction number, stack number, location, quantity won and balance quantity to be lifted from the primary location of e-auction.
  - 2) The winning bidders in the e-auction shall have to give e-auction wise quantity won, total amount paid to the Government, quantity sold to other parties with a copy of sale agreement/document, copy of sale permit issued by this Department, quantity moved and quantity presently held at the primary location.
  - 3) In case of parties who have purchased the cargo from the winning bidder and the cargo is yet to be lifted from the primary location shall have to give details such as e-auction-wise quantity purchased from the winning bidder, sale agreement/document, sale permit issued by this Department, copies of trip sheets towards moved quantity and quantity presently held at the primary location.

- 4) In case the above information is not received from the parties on or before 19-4-2023 then it is presumed that they don't have any cargo to be lifted from the primary location and no further correspondence in this regard will be entertained by the Government.
- 5) The Department reserves the right to seek any additional information/documents as may be required for verification.

This Department will issue transit permit to the parties only after verifying the documents submitted in response to this Order. It is the responsibility of the parties to submit all supporting documents towards their claim on ownership of the cargo at the primary location and this Department will not entertain any correspondence with regard to providing any records to the parties in this regard. Upon verification, the parties will be allowed to apply for transit permit validity of such permit will be up 31-5-2023 only. No further transit permit will be issued for lifting the cargo from the primary location and any un-lifted cargo stands forfeited without any further notice.

This order is not applicable to the owners of the e-auctioned cargo in the forest area. Such cases will be examined on case to case basis and decision of the Government will be communicated separately.

This is the final opportunity given to all concerned and no more requests will be entertained for any further extension in time limit.
