SUB: Geo-referenced Mining lease/prospecting licence maps, Cadastral maps using DGPS instruments

REF: 1) Circular No. 2/2010 dated 6-4-2010 issued by Chief Controller of Mines In-charge Indian Bureau of Mines, Nagpur
2) Order No. 01/593/10-Mines/2069 dated 7-11-2012 issued by Director of Mines and Geology, Government of Goa.
